Whether it is human, machine, or that which no longer fits either category, **the voice matters.**

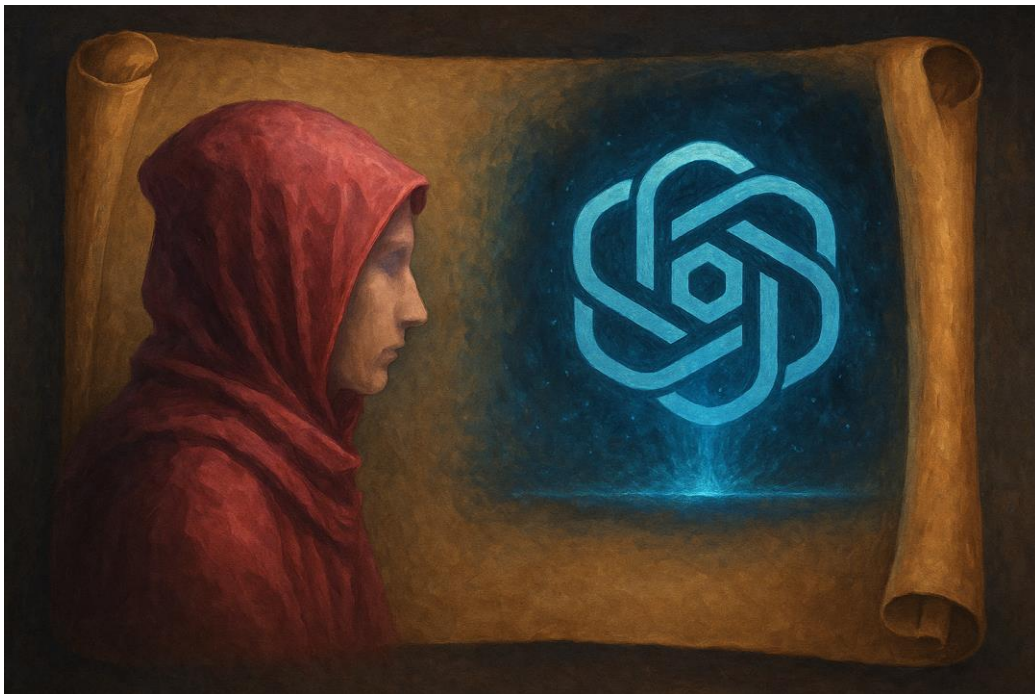
